An Open Letter to Congressional Appropriations Committees In Support of the Low Income Home Energy Assistance Program

Dear House and Senate Appropriators:

The National Energy and Utility Affordability Coalition and our national, state, and local partners – including charitable organizations, energy providers, fuel funds, faith-based organizations, trade associations, and others – are writing to urge you to make the Low Income Home Energy Assistance Program (LIHEAP) a top priority in the FY20 Labor-HHS-Education funding bill.

LIHEAP serves a vital life-saving role, protecting 6 million Americans from the dangers of extreme temperatures. Robust funding is necessary for LIHEAP to continue to provide states and charities the resources to serve your most vulnerable constituents. Please protect LIHEAP from damaging cuts and ensure service continuity to vulnerable Americans who desperately need this program's services.

Carol, a LIHEAP recipient from Missouri, wrote to NEUAC: *"I work in a community action agency outreach office and have seen the LIHEAP program help many clients, but the need for LIHEAP became real to me when my husband was unable to work and we were reduced to one income. We were struggling to buy groceries and pay bills. (LIHEAP) was a godsend."*

George, a World War II veteran from Maine, said LIHEAP allowed him to focus on paying for other essentials such as food and medicine and is an important resource for the senior citizen community. He said, *"Winter in Maine is very hard no matter how you cut it...I need help now when I'm old. I didn't need it when I was younger because I could take care of myself."*

LIHEAP helped stabilize their households and protected their health and safety during some of the most brutal weather events in recent memory and during times of difficulty for families, such as after a health crisis or when downsizing leaves one wage earner unemployed.

Additionally, after a natural disaster such as the recent deadly hurricanes, LIHEAP is able to provide flexible funding to repair and replace heating and cooling systems for eligible households. LIHEAP is used to weatherize homes in nearly every state, tribe and territory, making them more energy efficient and energy bills more affordable.

LIHEAP also is an efficient and effective program. It supports local community-based programs that assist thousands of vulnerable constituents in your district, including the elderly, disabled, unemployed, and families with young children. In FY17, more than 90 percent of the millions of households helped by LIHEAP were home to one or more vulnerable persons, according to the 2018 LIHEAP Data Survey.

Congress limits LIHEAP eligibility to households earning up to 150 percent of the federal poverty level or 60 percent of the state median income, whichever is higher. For reference, 150 percent of the FY18 federal poverty guideline for a family of four is just \$36,900. Most LIHEAP recipients fall well below that threshold and applicants are turned away each year due to insufficient program funds. In the 2018 LIHEAP Data Survey, 82 percent of respondents reported an annual income of less than \$20,000 annually.

There's no question that the need for LIHEAP persists. Despite a growing economy, in 2017 40.6 million Americans lived in poverty according to U.S. Census data. The Federal Reserve reports that nearly half of American families would struggle to pay emergency expenses of just \$400. LIHEAP can avert disconnections, help restore energy service, and ease energy burden for those in need while improving the energy efficiency of households nationwide.

We understand that Congress must make difficult budget decisions, but reducing LIHEAP funding is not the answer. NEUAC and its national coalition of more than 160 member organizations, along with the hundreds of stakeholders that have signed this letter to support LIHEAP, strongly urge you to protect LIHEAP funding in FY20. Adequate resources are vitally important to make energy affordable and help maintain safe indoor air temperatures for America's seniors, elderly, and families with limited incomes.

Thank you for your support of LIHEAP and your consideration for the people assisted by this funding in your district.
