EDITORIAL NOTES FOR THE HISTORICAL RECONSTRUCTION OF PARTS 191 AND 192

Part 191 became effective on February 9, 1970. Part 192 became effective on November 12, 1970. Subsequent amendments have been issued with some adding new sections and some amending pre-existing sections.

To aid the user in reconstructing the history of a particular section, the user is advised that the complete text of Parts 191 and 192 as originally issued, plus all amendments through 1994 are available at www.phmsa.dot.gov/pipeline/rulemakings/archived-pipeline-rulemakings. Amdts. 191-15 and 192-93, are contained in AGA-X69804, "Historical Collection of Natural Gas Pipeline Safety Regulations." Otherwise, Refer to the *Federal Register* website for amendments after 1994.
